

## Legislation Moving Forward

I have several bills that I introduced this session which are moving forward at the Capitol. All of them have passed the first round of committee hearings with a unanimous vote. One of the bills, SB 2365, has already been passed unanimously by the full Senate and now will be considered by the House. Please contact me if you're interested in weighing in on any of these bills or other legislation.

- SB 2363** would better protect mentally handicapped individuals by holding sexual predators "strictly liable" for their crimes.
- SB 2364** would authorize the issuance of special purpose revenue bonds of up to \$30 million for construction of educational facilities at Island Pacific Academy in Kapolei.
- SB 2367** would prohibit uninsured motorists and drunk drivers from receiving non-economic damages "pain and suffering" when they're involved in a car accident.
- SB 2373** would require retailers to maintain an electronic log of pseudoephedrine sales – a primary ingredient in making "ice".
- SB 2924** would appropriate additional funding to UH's College of Tropical Agriculture and Human Resources to hire additional staff to support organic agriculture.
- SB 2925** would set up a State Organic Program under the Department of Agriculture to develop and expand the organic agriculture industry.
- SB 2926** would increase penalties for driving ATVs and other vehicles on our beaches and public lands.
- SB 2365** would allow hybrid and other alternative fuel vehicles to use HOV lanes regardless of the number of passengers in the vehicle.
- SB 2366** would prohibit texting or emailing using a wireless communication device while driving.
- SB 3234** would require an ignition interlock device to be installed in the cars of drunk drivers.



**Coordinating Fundraising Efforts for the Hawaii Food Bank .....**

I was happy to be chosen by Senate President Colleen Hanabusa to head up the Senate's efforts in the Hawaii Foodbank 2008 Food Drive. Our goal is to raise \$5,000 in monetary donations and collect 1,500 lbs of food to support this important cause. **Target's Kapolei Store Opening Soon .....**

It was a pleasure to present Mr. Bryan Berg, Senior Vice President, of Target Co. an honorary certificate from the State Senate in recognition of the Groundbreaking Ceremony for their Kapolei Commons Store (located mauka of Honolulu Advertiser building) on January 24th. I welcomed Target because they have a national reputation for their commitment to the communities they serve. I also support their goal of using environmentally-friendly solar panel systems to supply electricity to the store. Plans are to have the store, which will be the first in Hawaii, open by March 2009.

**Honoring Malcolm Ching .....**

I was honored to present a certificate from the State Senate to Mr. Malcolm Ching on the floor of the Senate Chambers on February 13th. Mr. Ching is the General Manager of the Waikele Community Association and was recently selected by representatives from *Business Management Hawaii* magazine and six industry associations as the first ever Property Manager of the Year.



He originally earned statewide recognition and media attention for his role in forming Hawaii's first fast response graffiti team called Taking Action Against Graffiti (TAAG). In March of 2004, he formed TAAG with just 5 Waikele homeowners and a few buckets of donated paint. Now the TAAG team has more than 40 members who have made it their mission to keep their neighborhoods graffiti-free. TAAG has cleaned up over 700 graffiti damaged areas in Waikele and Waipahu.

Mr. Ching has been asked to speak to other anti-graffiti groups about his success. He also meets with community leaders to discuss tougher sentences for convicted taggers and works with the Honolulu Police Department to more effectively fight back against graffiti.



**Honoring a True Hero .....**

It was a privilege to recognize Kapolei resident and hero Christopher Ulu on behalf of the Hawaii State Senate at a special family luncheon on February 7th. Mr. Ulu rescued a woman who was being attacked while entering her vehicle in the Don Quijote parking lot in Waipahu on December 13, 2007. The male assailant forced her door open and attempted to shove her into the passenger's seat. Christopher, without any hesitation, rescued the victim from an unknown fate of torment, suffering, and conceivably an early demise.

Caring for others is the core of Hawaii's famed 'Aloha Spirit.' It takes a strong person like Chris who possesses both empathy and compassion to help a complete stranger. Christopher's wife Francine organized the surprise celebration at Dave & Busters at Ward Center in Honolulu so that many family and friends could join me in honoring Chris.



## Organic Bills Good for Our Bodies and the Environment

You may have noticed that more and more of our supermarkets are carrying organic foods. You might be surprised to learn that over the past decade, sales of organic products have shown an annual increase of at least 20% - making organics the fastest growing sector of agriculture. For example, in 2005 retail sales of organic foods and beverages was \$12.8 billion in the U.S.



My family and I have been eating organic foods for many years. We appreciate the benefit of eating healthy foods that are free of toxic substances, such as conventional pesticides. We also like the idea of supporting organic farmers whose agricultural methods promote sustainability, enhance soil health, and preserve our natural environment.



You might not be aware, but all the organic foods on supermarket shelves that bear the organic label have to meet USDA certification standards which were established in 2002. Hawaii's principal certifier for organic farms is the Hawaii Organic Farmers Association (HOFA).

In 2004, while I was a member of the Honolulu City Council, I authored legislation which put the City on record in support of organic agriculture. Hawaii has a strong history of organic farming. Today, we have close to 200 organic farms located on five islands: Hawaii, Kauai, Maui, Molokai, and Oahu. Our organic farms range in size from 1-acre to 1,725-acres. Some of their principal products include coffee, macadamia nuts, banana, pineapple, ginger, mango, avocado, and salad greens. It's estimated that Hawaii's organic agriculture is a \$5-\$10 million a year industry.

Right now, there's an increasing demand for organic foods that exceeds our local supply. In order to meet this demand, supermarkets are importing organic foods from the mainland and other countries. However, this situation leaves us vulnerable to bringing in invasive species which have the potential to harm our environment. By expanding our local organic industry, Hawaii has a great opportunity to prevent this problem and also allow us to become more sustainable by growing our own food.



In consultation with HOFA and the Hawaii Cooperative of Organic Farmers, I've introduced two bills this legislative session to help strengthen and grow organic agriculture in our state. The first bill, SB 2925, establishes a State Organic Program under the direction of the Department of Agriculture. The bill would also require the Department of Agriculture to come up with and implement a plan to develop and expand the local organic agricultural industry.



The second bill, SB 2924, appropriates funding and directs the UH College of Tropical Agriculture and Human Resources to hire additional researchers and specialists to support organic agriculture research and teaching programs.

I'll be working with my colleagues in the House and Senate over the next several months to get this important legislation passed. So next time you're shopping, think about buying some of our locally grown organic produce.


# Community Happenings .....
